

2. Candidate must have minimum "GOOD" ACR (Annual Confidential Report) rating in all for immediately preceding 03years i.e. 2020-21&2021-22 & 2022-23.
3. Vigilance/ Departmental Clearance of candidate should be "Clear"

### How to apply:

1. Candidates are advised to apply as per the prescribed Format (Annexure-A) for selection for HMV Training which is available on CCL website (www.centralcoalfields.in) under "What's New" tab.
2. Candidates are advised to go through the provisions of the internal notification carefully for assessing his /her eligibility in accordance with the qualification, other norms, caste etc.
3. **The last date of receipt of the application in the office of HOD (P-MP), CCL, Ranchi will be on 29.02.2024.**
4. All the relevant documents duly self-attested (educational certificates, caste certificates, etc) should be annexed with the application & submitted through proper channel in the office of HOD (MP), CCL, Ranchi.

### Mode of Selection:

1. The Selection for HMV Training of eligible employees will be made through a Committee constituted at HQ level consisting of HOD (P&IR), GM(Excv.) & GM(HRD). HOD (MP) will co-ordinate the whole process.
2. After selection the concerned will be imparted HMV Training arraigned by the Management.
3. On obtaining HMV License they will be further selected as per the applied post as per cadre scheme, vacancy and other criteria.

### Cost of HMV Trainee

1. **The selected candidates will be sent to training institute for obtaining HMV License by the Management. The cost of training will be borne by employee. However, it will initially be borne by Management which will be recovered in 12 monthly instalments after their selection to the post applied for. The cost of training is approx Rs. 28,000/-(Twenty eight thousand only)**

### General Information and Instructions:

1. The cut-off date for the minimum qualification i.e. Matriculation for Crane Operator (T), Excv. Cat-D/Dozer Operator, Excv. Cat-D/Dumper Operator, Excv. Cat-D will be date of issue of this internal notification dated 31.01.2024. (Illustration: The date of issue of internal notification is 31.01.2024 then the cut off date for eligibility of any permanent employees would be 31.01.2024.
2. The selected candidates are eligible for pay protection as per rule.
3. Candidates shall note that at any stage of Selection/Training or later, if a candidate is found indulging in any misconduct, there candidature will be summarily rejected and disciplinary action as per the Certified Standing Order will be initiated apart from any other legal course of action as deemed fit.
4. Canvassing at any stage will lead to disqualification of the candidature.
5. CCL Management reserves the rights to modify/ alter/ restrict/ cancel the selection process, at its discretion without assigning any reason whatsoever. CCL Management reserves to modify the vacancy position under special circumstances. The decision of the D(P), CCL will be final and no appeal will be entertained in this regard.
