Sub: Transparency in allotment of Quarter.

Sir,

1. A lot of complaints are coming to this office regarding irregularities in the allotment of quarter in the command area of CCL.
2. During the meeting conducted by CVC on 22.09.2020, CVC had mentioned that one of the focus area during this year Vigilance Awareness Week will be transparency in system and specific reference to transparency in house allotment was made.
3. CCL is having online information regarding quarter allotment for which special link directing to e-AWAS portal is available on the official Website of CCL.
4. The portal was examined and it was noticed that the information available in the e-AWAS portal is not being updated properly inasmuch as for most of the areas, the details of occupants are appearing as blank.
5. It is suggested that following action may be taken immediately to make the portal relevant:
 - (i) All the missing details are filled up immediately before the commencement of Vigilance Awareness Week i.e. before 25.10.2020.
 - (ii) Under occupant type heading, if the occupation is unauthorised, the same should be mentioned as '**UNAUTHORISED**' instead of the current practice of marking as '**PUBLIC**'.
 - (iii) Two more fields regarding the present place of posting and date of retirement of employee may also be added.
6. It is requested that the above exercise is completed before the commencement of Vigilance Awareness Week so that this can be emphatically presented as an important activity carried out during this year Vigilance Awareness Week.
